RESOLUTION NO. 2840

ADOPTED ON MAY 4, 1998

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE PROPOSED REDEVELOPMENT PLAN FOR THE NORTH BAY REDEVELOPMENT PROJECT, APPROVING THE REPORT TO THE CITY COUNCIL (INCLUDING THE IMPLEMENTATION PLAN) PERTAINING THERETO, AND AUTHORIZING SUBMISSION OF THE PROPOSED REDEVELOPMENT PLAN AND THE REPORT TO THE CITY COUNCIL, TO THE COUNCIL OF THE CITY OF SAN DIEGO.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has prepared a proposed Redevelopment Plan for the North Bay Redevelopment Project (the "Project"); and

WHEREAS, the proposed Redevelopment Plan conforms to the requirements of the California Community Redevelopment Law (Health and Safety Code section 33000 et seq.); and

WHEREAS, after due notice as provided by the California Community Redevelopment Law, a joint public hearing was held by the Agency and the Council of The City of San Diego (the "Council") to consider the proposed Redevelopment Plan; and

WHEREAS, the Agency intends to submit the proposed Redevelopment Plan for the Project to the Council for consideration of its approval and adoption; and

WHEREAS, the proposed Redevelopment Plan, when submitted by the Agency to the Council, shall be accompanied by a report containing the information provided for in Section 33352 of the California Community Redevelopment Law; and

WHEREAS, the Agency has prepared the Report to City Council on the Project, including without limitation the Implementation Plan for the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

- 1. That the proposed Redevelopment Plan for the North Bay Redevelopment Project is approved.
- 2. That the Agency recommends that the proposed Redevelopment Plan for the Project be approved and adopted by the Council.
- 3. That the Report of the Agency to the Council on the proposed Project, including without limitation the Implementation Plan for the Project, is approved.
- 4. That the Executive Director of the Agency, or designee, is authorized and directed to submit the proposed Redevelopment Plan for the Project, to the Council.
- 5. The Executive Director of the Agency, or designee, is further authorized and directed to submit the Report of the Agency to the Council on the proposed Project, to the City Council.
