A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO REGARDING THE PROGRESS OF THE SAN YSIDRO REDEVELOPMENT PLAN AND IMPLEMENTATION PLAN FOR THE SAN YSIDRO REDEVELOPMENT PROJECT.

WHEREAS, the California Community Redevelopment Law (codified in California Health and Safety Code section 33000 et seq.) requires that redevelopment agencies adopt five (5) year Implementation Plans for all redevelopment projects adopted before January 1, 1994; and

WHEREAS, in accordance with the California Community Redevelopment Law [Law], the Redevelopment Agency of The City of San Diego [Agency] adopted an Implementation Plan for the San Ysidro Redevelopment Project area by Resolution No. 2642, approved April 2, 1996; and

WHEREAS, Section 33490 of the Law requires that a redevelopment agency hold a public hearing, no earlier than two (2) years or more than three (3) years after the adoption of an Implementation Plan, to review the Implementation Plan and hear all written and oral testimony that may be presented on it and underlying the Redevelopment Plan, in order to evaluate the progress of the Implementation Plan and the Redevelopment Plan; and

WHEREAS, on July 20, 1999, the Redevelopment Agency of The City of San Diego held a public hearing, noticed pursuant to the provisions of California Government Code section 6063, for the purpose of evaluating the San Ysidro Redevelopment Plan and Implementation

Plan for the San Ysidro Redevelopment Project; and

WHEREAS, at the public hearing, the Agency heard and considered Report No. RA-99-5

to the Agency, and all written and oral testimony presented at the public hearing regarding the

San Ysidro Redevelopment Plan and the Implementation Plan for the San Ysidro Redevelopment

Project; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, that it

adopts as its conclusions, the conclusions contained in the document titled "The San Ysidro

Redevelopment Project" regarding the progress of the San Ysidro Redevelopment Plan and the

Implementation Plan for the San Ysidro Redevelopment Project; a copy of which is on file in the

office of the Secretary to the Agency as Document No. D-03017.
