  - 5. Description of where the department currently stands in the process of filling each budgeted vacancy (for example, conducting interviews)

- 4. If high-priority resources are identified for either the FY 2014 Mid-year budget monitoring discussion or the FY 15 Budget review discussions inform the committee at the March 12, 2014 meeting.
- 5. A needs assessment should be included in the draft Strategy document.
- 6. Include a commitment in the draft Strategy to report back semi-annually on progress to committee, and annually with an update to the full City Council.
- 7. Working in conjunction with the City Attorney's Office, review compliance with California Proposition 26, "Supermajority Vote to Pass New Taxes and Fees Act," relating to Business Improvement Districts and Property-based Business Improvement District policies noted in the draft Strategy
