ITEM-2: Report from SEDC and CCDC regarding Recommendations for RESTRUCTURING OVERSIGHT OF SEDC AND CCDC

ITEM-3: Report from the Independent Budget Analyst regarding Council's Proposed RESPONSE TO GRAND JURY REPORT TITLED "TIME FOR REPEAL OF THE PEOPLE'S ORDINANCE"

ACTION: Motion by Councilmember Frye, second by Councilmember Young, to approve the IBA response to the Grand Jury Report titled, "TIME FOR REPEAL OF THE PEOPLE'S ORDINANCE", with direction to the IBA and the City Attorney's office to revise Finding 01 to Partially Disagree with the following language: "City trash collection services are paid for from the General Fund, while City recyclables and greenery collection services are paid for from the Recycling Fund. The General Fund is made up of property taxes, sales taxes, transient occupancy taxes, and other fees and taxes paid by City residents and businesses.

### ACTIONS Committee on Rules, Open Government, and Intergovernmental Relations July 15, 2009 - 3 -

City residents and businesses that are eligible to receive City collection services do not pay a fee for those services over and above their contributions to the General Fund. However, most multi-family residential facilities, some single family residents, and most businesses pay a fee for private collection services in addition to their contributions to the General Fund because they are not eligible for City collection services." Revise Finding 02 to include language that reflects pension costs associated with trash collection services. Revise Recommendation 09-02 with language from the IBA and City Attorney to reflect Committee discussion.
