ACTION: Direction was given to the City Attorney's Office to return to the next Rules Committee Meeting with the following:

- Housekeeping changes to the Charter where references to the "City Manager" should be "Mayor" are used.
- Change the title of the Ballot Measure/Article XV from "Strong Mayor" to "Strong Mayor/Strong Council" or "Mayor/Council" form of government.
- Review the appointments procedure to allow Councilmember appointments to outside organizations stay within the confines of the Council body. City Attorney should return with a proposal on how to clarify this within the Charter.
- City Attorney should return with a proposal, where the word "promptly" and "lawful requests" are defined within Article V, Section 32.1 of the City Charter.
- City Attorney should refer to the October 14, 2009 Memorandum to be distributed by Council President Ben Hueso for further clarification.
