Subject matter and time limitations are noted on the form. Pursuant to open meeting laws, no discussion or action other than a referral shall be taken by the Committee on any issue brought forth under Public Comment.

<u>REQUESTS FOR CONTINUANCE</u>: Members of the public may request an item be postponed or rescheduled by submitting a "Request to Speak" form prior to the meeting and asking that the matter be "continued." The decision whether to continue the matter is at the Committee's discretion.

<u>CONSENT AGENDA</u>: The Chair may entertain a motion by a Committee Member to approve certain noncontroversial agenda items as consent agenda items at the beginning of the meeting.
