

REPORT TO THE HONORABLE
MAYOR AND CITY COUNCIL
IN THE MATTER OF THE NOVEMBER 3, 1987
MUNICIPAL ELECTION

On Monday, July 20, 1987, you will be discussing the above-captioned subject and the preparation of the ordinances calling the Special Election for Council consideration on July 27, 1987.

Because of the numerous proposals which are to be considered this year, we thought it best to summarize them for you here and include them within draft ordinances for your consideration. Enclosures (1) and (2).

ITEM 1. - AN ORDINANCE AMENDING THE SAN DIEGO MUNICIPAL CODE BY ADDING THE FOLLOWING SECTIONS RELATING TO RESTRICTING THE USE OF MISSION BEACH PARK

This proposition has resulted from an initiative petition which was duly qualified on February 23, 1987. See pages 2 through 6 of Enclosure (1).

ITEM 2. - AN ORDINANCE AMENDING THE SAN DIEGO MUNICIPAL CODE BY ADDING THE FOLLOWING SECTION RELATING TO IRREVOCABLY RENAMING THE AFFECTED STREET AS MARKET STREET

This proposition has resulted from an initiative petition which was duly qualified on March 26, 1987. See pages 6 and 7 of Enclosure (1).

ITEM 3. - AMENDMENT OF THE PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO PURSUANT TO THE PROVISIONS OF THE PLAN ADOPTED BY THE VOTERS ON NOVEMBER 6, 1985

This proposition is before you as a result of the request of the La Jolla Valley project developer attorney's request of May 19, 1987. See page 7 of Enclosure (1).

ITEM 4. - AN ORDINANCE OF THE PEOPLE OF THE CITY OF SAN DIEGO CHANGING THE APPROPRIATIONS LIMIT FOR THE FISCAL YEARS 1988 THROUGH 1991

This proposition is before you as the result of a City Manager recommendation to the Rules Committee in which the Committee concurred. See pages 7 and 8 of Enclosure (1).

ITEM 5. - BALBOA PARK AND MISSION BAY PARK

These propositions are before you as a result of Council action on June 23, 1987 per Resolution R-268655 and are attached in Enclosure (2).

ITEM 6. - CLEAN AIR INITIATIVE

This proposition, which has not been included in the draft, failed to qualify under the initiative petition requirements of the Code. However, The Charter requires that you consider placing it on the ballot. The language of the initiative is attached as Enclosure (3).

ITEM 7. - CIGARETTE SALES TAX

The Rules Committee directed us to present a proposal which would cause a sales tax of 10% to be imposed upon the sale of cigarettes within the City. If that recommendation is approved by the Council today, we will include it within the ordinance for consideration on July 27, 1987.

ITEM 8. - CHARTER AMENDMENT - SECTION 55

The Mayor has proposed an amendment to City Charter section 55 as follows:

Dedicated parkland shall not be used for any but free and open park purposes, including only those facilities which support park uses.
