REPORT TO THE HONORABLE
MAYOR AND CITY COUNCIL
IN THE MATTER OF THE JUNE 5, 1990
SPECIAL MUNICIPAL ELECTION FEBRUARY 26, 1990 DOCKET ITEM S404

Pursuant to your request, the City Attorney and City Manager have prepared the various ordinances and resolutions which, if approved by this City Council, will place certain proposals before the voters at the June 5, 1990 election. Copies of the documents you are considering are enclosed in the following order:

- 1. Enclosure (1) is a copy of proposed Ordinance No. O-90-149 which contains the following:
 - a) A proposition which would amend Sections 4 and 12 of the Charter to increase the number of Council Districts from 8 to 10 for the 1993 elections. (See pages 4 and 16.)
 - b) A proposition which would amend Section 5 of the Charter to provide for a one-time waiver of the four-year redistricting limitation. (See pages 7 and 17.)

(These amendments are being placed on the ballot to meet the City's obligations in the court approved settlement agreement in Perez et al. v. City of San Diego et al.)

- c) A proposition which would increase the City's appropriation limit under Article XIIIB of the State Constitution for Fiscal Years 1992-1995 to \$592,000,000. (Gann Waiver) (See pages 9 and 18.)
- d) A proposition which would amend the People's Ordinance relating to the collection, transportation and disposal of City refuse; providing for the imposition of fees for these services and requiring the City Council to provide for discounts or incentives to promote recycling and resource conservation. (See pages 13 and 19.)
- e) A proposition which would ask the voters to advise the City Council on whether to levy a utility users' tax not to exceed 5 percent on commercial and industrial users. (See pages 14 and 22.)
- 2. Enclosure (2) is a copy of proposed Resolution No. R-90-1373, a Resolution of Necessity for acquisition and construction of police, fire and other public safety communications and dispatch facilities. (Requires 2/3's vote of

Council.)

- 3. Enclosure (3) is a copy of proposed Ordinance No. O-90-152 which calls for a Special Municipal Bond Election on June 5, 1990 to submit to qualified voters one proposition to incur general bonded indebtedness for police and fire and other public safety communications and dispatch facilities. (Requires 2/3's vote of Council.)
- 4. Enclosure (4) is a copy of proposed Ordinance No. O-90-150 which provides for the levy of a special tax for police protection services subject to two-thirds vote and calling for a special election on June 5, 1990. (Requires 2/3's vote of Council.)
- 5. Enclosure (5) is a copy of proposed Resolution No. R-90-1374 which requests consolidation of the Special Municipal Election with the Statewide Primary Election to be held on June 5, 1990.
