## PROPOSED BALLOT MEASURE NEW CHARTER SECTION 63

7 (a)(1) Creates a Branch Library Endowment Fund from the City's share of sales tax proceeds, less \$65 million.

7 (a)(2) Requires the \$65 million to be deposited into an interest-bearin

7 (a)(3) Requires the tax proceeds to be allocated between the Endowment

Funds according to the formula set forth in Sections 63(a)(3)(A) and (B).

investment oversight for the Endowment Fund. The Funds Commission will ens annual independent audit of the Fund.

7 (e)(1) Starting in 1998, requires five thousand dollars (\$5,000) to

earned on the Endowment Fund to be placed in a discretionary fund for any b

the City Librarian, or his or her designee, after consultation with City-re groups, deems appropriate. Requires the discretionary fund allocation to e increase from the previous fiscal year by a factor equal to the percentage Price Index from the preceding calendar year. Prohibits more than three (3 discretionary funds for any particular branch library. Requires the annual Endowment Fund for these discretionary funds to be the first priority of ex the Fund.

7 (e)(2) Requires the City's Board of Library Commissioners to recommend

City Council how the income from the Endowment Fund should be spent annuall minimum of fifty percent (50%) of available income to be spent annually for purposes.

7 (f)(1) Beginning in FY 1998, requires the City to allocate funds for br

same percentage of General Fund Revenues, as was allocated in FY 1997. Pro the allocation in the event of expansion, additions or deletions of branch known as a "maintenance of effort" clause.

7 (f)(2) Upon two-thirds (2/3) vote and provided the City Council makes s

necessity for modification, in any given fiscal year, the City Council may branch libraries required by Section 63(f)(1).

7 In a paragraph that will not be codified in the Charter, provides notic

measure will be void if the County sales tax measure does not pass.
