# NOTICE OF RIGHT TO APPEAL

## ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Special Event Permit – St. Patrick’s Day 10K/4 Mile/2 Mile Run/Walk

**COMMUNITY PLAN AREA:** Mission Bay Park Master Plan

**COUNCIL DISTRICT:** 2

**LOCATION:** Fiesta Island and portions of Mission Bay Park

**PROJECT DESCRIPTION:** Special Event Permit for a 10K/4 Mile/2 Mile Run/Walk race event that would include three race routes, a fenced-in beer garden, entertainment, and the temporary use of canopies, tables, and chairs in Mission Bay Park on March 11, 2017. Noise associated with the event activities and set-up/dismantling would occur from 5 AM until 12 PM on March 11, 2017. The 10K run would begin on East Mission Bay Drive south of the Hilton Hotel, travel south to Fiesta Island Road, loop around Fiesta Island, and then onto the sidewalk heading north to the finish line in the grassy area with the gazebo between the Hilton Hotel and the Visitors Center. The two and four mile events would begin on East Mission Bay Drive, travel south to Fiesta Island, then turn onto the sidewalk headed north. At this point, the two miler would end, the four mile run would continue north on the sidewalk to the turnaround point and then back to the same finish line for all races. On March 11, 2017, road closures associated with this event would include Fiesta Island Road from 6 AM until 9 AM, and East Mission Bay Drive between the Hilton Hotel and SeaWorld Drive from 6 AM until 10:30 AM. A public announcement system would be used for announcements/entertainment, and sound amplification would occur from 6:30 AM until 10 AM. On March 11, 2017, set-up would occur from 5 AM until 7:45 AM, the event would occur from 7:45 AM until 10 AM, and dismantling would occur from 10 AM until 12 PM.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor–Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
