NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Right-of-Entry Permit for San Diego County Sherriff Department Diver Training

COMMUNITY PLAN AREA: Unincorporated communities throughout the County of San Diego

COUNCIL DISTRICT: Unincorporated communities throughout the County of San Diego

LOCATION: The Right-of-Entry Permit will allow access to all nine City of San Diego owned reservoirs located across the County of San Diego.

PROJECT DESCRIPTION: Authorize the City of San Diego to issue a Right-of-Entry Permit to the San Diego County Sherriff Department for the purposes of diver training at City owned water reservoirs. The permit is month-to-month for up to three years and will allow training for Underwater Search and Recovery, Selection of Search Patterns, Underwater Investigation, and Dive Team Management and Organization.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego - Public Utilities Department

ENVIRONMENTAL DETERMINATION: This activity is categorically exempt from CEQA pursuant to CEQA Guidelines, Section 15301 – Existing Facilities.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: This activity has been determined to be exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), a Categorical Exemption which allows for the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency determination.
