NOTICE OF APPLICATION

As a property owner, tenant, or person who has requested notice, you should know that an application has been filed with the City of San Diego for a Conditional Use Permit (CUP) and Planned Development Permit (PDP) Process 4 to modify an existing Wireless Communications Facility (WCF). The WCF will consist of removing three (3) existing panel antennas and installing six (6) new panel antennas measuring 33.1" x 20.6" x 8.3" and 8.38" x 7.87" x 4.92". The project also retains 9 existing panel antennas, totaling fifteen (15) panel antennas after modifications. Also, the WCF will consist of installing three (3) new Remote Radio Units (RRUs) and retaining six (6) existing RRUs, with a total of nine (9) RRUs, all on an existing mono-eucalyptus. Additionally, the project includes ancillary equipment for support to the WCF, including removing one (1) equipment cabinet. The existing 237.2-square-foot equipment enclosure is located at grade. The project is located at 12227 Spring Canyon Road in the RS-1-8 Zone and Scripps Miramar Ranch Community Plan area.
