As a property owner, tenant, or person who has requested notice, you should know that an application has been filed with the City of San Diego for a Process Four (Planning Commission Decision) Site Development Permit and Neighborhood Development Permit for the development of two (2) Research and Development commercial buildings (Building 1 & 2) over two (2) existing undeveloped legal lots separated by Mira Sorrento Place. Building 1 will consist of seven-stories (7) totaling 251,748 square feet (SF) with four (4) levels of below-grade parking; Building 2 will consist of five-stories (5) totaling 164,955 with five (5) levels of below-grade parking; one (1) on-grade central utility plant; and associated site improvements located at 0 Mira Mesa Boulevard (APN 341-352-2800) and 5031 Wateridge Vista Drive (APN 341-010-2800). The 13.93-acre project site is in the IL-2-1 (Industrial – Light) and OR-1-1 (Open Space – Residential) Base Zone, Airport Land Use Compatibility Overlay Zone for Marine Corps Air Station Miramar (MCAS), Airport Influence Area – Review Area One for MCAS Miramar, Airport Federal Aviation Administration Notification Area for MCAS Miramar), Community Plan Implementation Overlay Zone (A), Prime Industrial land, Parking Standards Transit Priority Area, Transit Priority Area within the Mira Mesa Community Area, Council District 6.
