NOTICE OF FUTURE DECISION DEVELOPMENT SERVICES DEPARTMENT

Development Services Staff will make a decision to approve, conditionally approve, modify, or deny an application for a Coastal Development Permit, Process 2 decision, to demolish an existing one-story single dwelling unit and a two-story three (3) dwelling unit apartment building, for a Complete Communities Residential Development for the construction of three (3) detached three-story multiple dwelling unit buildings totaling 18,201 square feet, consisting of five dwelling units each for a total of 15 dwelling units (including five affordable units) with parking at grade, and associated site improvements, located at 1505 Felspar. The 0.14-acre site is in the RM-2-5 (Residential-Multiple Unit) Base Zone, Coastal (Non-Appealable) Overlay Zone, Coastal Height Limit Overlay Zone, Sustainable Development Area, Complete Communities Mobility Choices - Mobility Zone 2, and Complete Communities Housing Solutions 2.5 Floor Area Ratio (FAR) within the Pacific Beach Community Planning Area. Council District 1. The project is requesting two incentives and four waivers for RM-2-5 zone regulations in accordance with San Diego Municipal Code (SDMC) Sections 143.1010. This development is within the Coastal Overlay zone and the application was filed on February 28, 2024. The project is being processed as an Expedite Program project for Affordable/In-Fill Housing and is eligible based on Council Policy 600-27 and SDMC Section 143.0915.

The decision by City staff will be made **without** a public hearing no less than thirty (30) calendar days after the date of mailing the Notice of Future Decision. If you wish to receive a "Notice of Decision," you must submit a written request to the Development Project Manager listed above no later than ten (10) business days from the date of this Notice. This project is undergoing environmental review.

The decision of the Development Services Department Staff is final unless appealed to the Planning Commission. The decision made by the Planning Commission is the final decision by the City. Appeal procedures are described in <u>Information Bulletin 505</u> (https://www.sandiego.gov/development-services/forms-publications/informationbulletins/505). Appeals to the Planning Commission can be filed by email/mail or in person:

- Appeals filed via email/mail: Send the fully completed appeal application <u>DS-3031</u> (<u>https://www.sandiego.gov/sites/default/files/legacy/development-services/pdf/industry/forms/ds3031.pdf</u>) (including grounds for appeal and supporting documentation in pdf format) via email to <u>PlanningCommission@sandiego.gov</u> by 4:00 PM on the last day of the appeal period. When received by the City, the appellant will be invoiced for payment of the required Appeal Fee. Timely payment of this invoice is required to complete processing of the appeal. Failure to pay the invoice within five (5) business days of invoice issuance will invalidate the appeal application.
- 2) Appeals filed in person: Bring the fully completed appeal application <u>DS-3031</u> (<u>https://www.sandiego.gov/sites/default/files/legacy/development-services/pdf/industry/forms/ds3031.pdf</u>) (including grounds for appeal and supporting documentation) to the touchless Payment Drop-Off drop safe in the first-floor lobby of the Development Services Center, located at 1222 First Avenue, San Diego, CA 92101 by 4:00 PM. on the last day of the appeal period. The completed appeal package must be clearly marked on the outside as "Appeal" and must include the required appeal fee per Information Bulletin 505 in the form of a check payable to the City Treasurer. This safe is checked daily, and payments are processed the following business day. All payments must be in the exact amount, drawn on US banks, and be made out to "City Treasurer." Please include in the memo of the check the invoice number or Project number or attach the invoice to the check. Cash payments are only accepted by appointment; email <u>DSDCashiers@sandiego.gov</u> to schedule an appointment.

The final decision by the City of San Diego is not appealable to the California Coastal Commission.

The project is being processed as Expedite Program project for Affordable/In-Fill Housing and is eligible based on Council Policy 600-27 and San Diego Municipal Code (SDMC) Section 143.0915.

Please note that Community Planning Groups provide citizens with an opportunity for involvement in advising the City on land use matters. Community Planning Group considerations are a recommended, but not required, part of the project review process.
