As a property owner, tenant, or person who has requested notice, you should know that an application has been filed with the City of San Diego for a Process Three (Hearing Officer decision) Site Development Permit for the proposed development of a 1,600,000-square-foot vehicular parking lot on two existing legal lots (APN: 667-060-1000 & 667-060-1500) consisting of 3,750 parking spaces (including 48 accessible spaces), and three pedestrian pick-up areas providing shuttle service to the Cross Border Xpress Terminal located at 8381 Siempre Viva Road. The 59.5-acre project site is in the IBT-1-1 (International – Business and Trade) Base Zone, Prime Industrial Land, Sustainable Development Area, Complete Communities Mobility Choices – Mobility Zone 2, Community Plan Implementation Overlay Zone – CPIOZ A, Parking Standards Transit Priority Area, Transit Priority Area, Airport Land Use Compatibility Overlay Zone for Brown Field, Airport Influence Area – Review Area 2 for Brown Field, Federal Aviation Administration (FAA) Part 77 Noticing Area for Brown Field, Paleontological Sensitivity Area, Multiple Habitat Planning Area (MHPA), Sensitive Vegetation, Environmentally Sensitive Area, Vernal Pools, Brush Management, and Very High Fire Hazard Severity Zone within the Otay Mesa Community Plan Area, Council District 8.
