PLEASE ACCEPT THIS AS A NOTICE TO INFORM YOU, as a property owner, tenant or interested citizen, that the Council of the City of San Diego, California will conduct a public hearing, as part of a scheduled City Council meeting, on the following project:

The Mitigation Fee Act requires an annual report on Development Impact Fees to be presented to the City Council. Specifically, the City is required to make specific information available to the public and establish certain findings related to Development Impact Fees that have been in the account and unspent for five years or longer. In compliance with these requirements, the item being heard includes accepting the Development Impact Fees Annual Report-Fiscal Year 2023 in accordance with California Government Code section 66006 and findings related to unexpended balances as required in California Government Code section 66001, including the allocation of funds for identified projects that serve the purpose of the projects for which the fees were originally imposed. In addition to a comprehensive report on Development Impact Fees, this item includes a request for Council authorization regarding repayment of a loan from the Torrey Highlands restricted Facilities Benefit Assessment Fund to the Rancho Peñasquitos restricted Facilities Benefit Assessment Fund, as well as a request for Council approval for appropriating Development Impact Fees towards a list of specific Capital Improvement Projects in Carmel Valley and North University City.

The proposed action to accept the DIF Annual Report for Fiscal Year 2023 and make findings pursuant to California Government Code sections 66001 and 66006, is not a project pursuant to CEQA Guidelines Section 15378(b)(5), as it is an organizational or administrative activity of government that will not result in direct or reasonably foreseeable indirect physical changes in the environment. As such, it is not subject to CEQA pursuant to CEQA Guidelines Section 15060(c)(3).

The proposed resolution to appropriate and spend funds from the Carmel Valley FBA and North University DIF is not a "project" pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15378(b)(4) as it is a government fiscal activity which does not involve any commitment to any new, specific project which may result in a potentially significant physical impact on the environment. Thus, this activity is not subject to CEQA pursuant to CEQA Guidelines Section 15060(c)(3). The appropriation and expenditure of these funds are fiscal activities that will not result in the commitment to any new, specific project that may cause a physical change in the environment. The Carmel Valley Community Park Turf Upgrades, Carmel Grove Neighborhood Park Comfort Station and Park, and the Coastal Rail Trail have received previous approvals which were reviewed under CEQA and these budgetary actions do not change the scope of those projects, so there is no potential for new environmental impacts which would need further evaluation under CEQA. For the median installation at the Carmel Mountain Road and Carmel Country Road Roundabout and the Carmel Country Road Low Flow Channel, environmental review per CEQA is in process and will be completed at the appropriate future time in accordance with CEQA Guidelines Section 15004.

The proposed action to transfer funds from Citywide Mobility Development Impact Fee Fund to Rancho Peñasquitos restricted Facilities Benefit Assessment Fund has been reviewed for consistency with Final Program Environmental Impact Report prepared for the Complete Communities: Housing Solutions and Mobility Choices (SCH No. 201906003, May 5, 2020), certified and adopted by City Council Resolution No. R-313279, on November 9, 2020. These activities are subsequent discretionary actions, and not separate projects for purposes of CEQA review as defined in CEQA Guidelines Section 15378(c). Pursuant to CEQA Guidelines Section 15162, there is no change in circumstance, additional information, or project changes to warrant additional environmental review for these actions
