PLEASE ACCEPT THIS AS A NOTICE TO INFORM YOU, as a property owner, tenant or interested citizen, that the Council of The City of San Diego, California will conduct a public hearing, as part of a scheduled City Council meeting, and UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS AND SERVICE EASEMENTS VACATION LAW AND FIXING A TIME AND PLACE FOR HEARING THEREOF, NOTICE IS HEREBY GIVEN that the Council of San Diego, California, will proceed under the provisions of the Public Streets, Highways and Service Easements Vacation Law to adopt a Resolution terminating the public right to use a certain street and/or easement as shown on drawing **101477-1-B** located at 5322 Alta Bahia Court for an approximate 14,698-square-foot area consisting of 60 feet wide by 231-foot long section on the western side of the lot, and will approve, conditionally approve, or deny an application for the following project:

An application for an Easement Vacation to vacate an approximate 14,698 square feet of slope easement along the western portion of the lot of 5322 Alta Bahia Court. The 0.82-acre project site is in the RS-1-4 (Residential-Single Unit) Zone, Complete Communities Mobility Choices (CCMC) Mobility Zone Two, Sustainable Development Area, Coastal Height Limit Overlay Zone, and Paleontological Sensitive Area within the Pacific Beach community planning area, Council District 1. This project was determined to be categorically exempt and not subject to the California Environmental Quality Act (CEQA) pursuant to CEQA Sections 15061(b)(3) (Commons Sense), and 15332 (In-Fill Development Projects).

The final decision by the City of San Diego is not appealable to the California Coastal Commission. If you want to receive a Notice of Final Action, you must submit a written request to the City Project Manager listed above.

The decision of the City Council is final.
