As a property owner, tenant, or person who has requested notice, you should know that a public hearing will be held by the Hearing Officer to consider an application for a Conditional Use Permit and Neighborhood Development Permit to continue the operation of an existing Wireless Communication Facility (WCF). The project proposes the continued use of an existing 40-foot-tall faux mono-broadleaf tree that houses 12 antennas and 12 Remote Radio Units (RRUs), and a 548-square-foot equipment enclosure, with no physical changes proposed to the existing facility. The site is an existing church located at 1765 Pentecost Way in the RM-2-6 Zone of the Mid-City Eastern Area Community.

The project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act on November 8, 2024, and the opportunity to appeal that determination ended November 25, 2024.

<u>APPEAL OF THE HEARING OFFICER DECISION:</u> The decision of the Hearing Officer is final unless appealed to the Planning Commission. The decision made by the Planning Commission is the final decision by the City. In order to appeal the decision, you must be registered as a speaker at the public hearing concerning the application or have expressed interest by writing to the Hearing Officer, HearingOfficer@sandiego.gov before the close of the public

hearing. Appeal procedures are described in Information Bulletin 505 (https://www.sandiego.gov/development-services/forms-publications/information-bulletins/505). Appeals to the Planning Commission can be filed by email/mail or in person:

1. Appeals filed via email

Send the fully completed appeal application <u>DS-3031</u> (including grounds for appeal and supporting documentation in pdf format) to <u>PlanningCommission@sandiego.gov</u> by 4 p.m. on the last day of the appeal period. When received by the City, the appellant will be invoiced for payment of the required Appeal Fee per this bulletin. Timely payment of this invoice is required to complete the processing of the appeal. Failure to pay the invoice within five business days of invoice issuance will invalidate the appeal application.

2. Appeals filed in person

Bring the fully completed appeal application <u>DS-3031</u> (including grounds for appeal and supporting documentation) to the touchless payment drop-off drop safe in the first-floor lobby of the Development Services Center, located at 1222 First Avenue, San Diego, CA 92101 by 4 p.m. on the last day of the appeal period.

- The completed appeal package must be clearly marked on the outside as "Appeal" and must include the required appeal fee per this bulletin in the form of a check payable to the City Treasurer. This safe is checked daily, and payments are processed the following business day.
- On the memo line of the check, write the project number and the appellant's name exactly as it is stated on the associated form DS-3031.
- Cash payments are only <u>accepted by appointment</u>.
