As a property owner, tenant, or person who has requested notice, you should know that a public hearing will be held by the Planning Commission to consider an appeal of the May 27, 2015, Hearing Officer's decision to approve an application for a Conditional Use Permit and Site Development Permit to operate a Medical Marijuana Consumer Cooperative in 400 square-foot tenant space within an existing 19,700 square-foot building located at 3703 Camino Del Rio South. The 0.93-acre site is in the Mission Valley Planned District Ordinance MVPD-MV-CO Zone, the Airport Influence Area (Montgomery Field) and the Airport Land Use Compatibility Overlay Zone within the Mission Valley Community Plan area and Council District 3.
