

RESOLUTION No. 186221

BE IT RESOLVED by the Council of The City of San Diego as follows:

That the deed of FRANK JACKSON PERKINS, JR. and BETTY LOU PERKINS, husband and wife, executed in favor of The City of San Diego, bearing date December 28, 1965, conveying to said City Lots 7 and 8 in Block 12 of GRANTVILLE and OUTLOTS according to Map thereof No. 776 filed in the office of the County Recorder, County of San Diego, together with that portion of the South 20 feet of Orcutt Avenue, now known as Logan Avenue, adjoining said lots on the North, being vacated and closed to public use, as more particularly described in said deed, be, and the same is hereby accepted on the conditions therein expressed.
