1. That the expenditure of \$19,500 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego solely and exclusively for the purpose of providing funds for planter lighting in Plaza de Panama, street lighting in El Prado and parking lot lighting at the Organ Pavilion in Balboa Park in the City of San Diego, and related costs.
