## ORDINANCE NO. 10225 (New Series)

AN ORDINANCE PREZONING PORTIONS OF LOTS 48, 49, 50, 64 AND 65, RANCHO MISSION OF SAN DIEGO, LOTS 1 AND 2 AND A PORTION OF LOT 3, BLOCK 45, AND LOTS 1, 2 AND 3, UNNUMBERED BLOCK, GRANTVILLE AND OUTLOTS (MISSION SAN DIEGO DE ALCALA ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA INTO A-1-1 ZONE AS DEFINED BY SECTION 101.0404 AND FC ZONE AS DEFINED BY SECTIONS 101.0402.1 AND 101.0402.2, OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 48, 49, 50, 64 and 65, Rancho Mission of San Diego, Lots 1 and 2 and a portion of Lot 3, Block 45, and Lots 1, 2 and 3, Unnumbered Block, Grantville and Outlots (Mission San Diego De Alcala Annexation), in the County of San Diego, California, within the boundaries of the districts designated "A-1-1" and "FC" on that certain Zone Map Drawing No. B-2225, filed in the office of the City Clerk under Document No. 730354 be, upon annexation to The City of San Diego, incorporated into A-1-1 Zone as defined by Section 101.0404 and FC Zone as defined by Sections101.0402, 101.0402.1 and 101.0402.2 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of Mission San Diego De Alcala Annexation, whichever is later.
