ORDINANCE NO. 10284 (New Series)

AN ORDINANCE INCORPORATING PORTIONS OF LOTS 4 AND 5, ALVARADO HEIGHTS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RV ZONE, AS DEFINED BY SECTION 101.0414 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13558, ADOPTED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 4 and 5, Alvarado Heights, in the City of San Diego, California, within the boundary of the district designated "RV" on Zone Map Drawing No. B-2267.1, filed in the office of the City Clerk under Document No. 731125 be, and they are hereby incorporated into RV Zone, as such zone is described and defined by Section 101.0414 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13558, adopted July 11, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
