ORDINANCE NO. 10290 (New Series)

AN ORDINANCE PREZONING PORTIONS OF SECTIONS 16, 21 AND 22, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., (NORTH MIRAMAR ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA INTO A-1-10 ZONE AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
