

ORDINANCE NO. 10309
(New Series)

AN ORDINANCE INCORPORATING A PORTION OF LOT 17, RANCHO MISSION OF SAN DIEGO, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1A, RP, R-5 AND R-3 ZONES, AS DEFINED BY SECTIONS 101.0431, 101.0419, 101.0418 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7854 (NEW SERIES), ADOPTED MAY 1, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a portion of Lot 17, Rancho Mission of San Diego, in the City of San Diego, California, designated "C-1A," "RP," "R-5" and "R-3" on Zone Map Drawing No. B-2269.1, is subdivided and a final one-lot subdivision map thereof duly recorded and within such subdivision, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0431, 101.0419, 101.0418 and 101.0411 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into C-1A, RP, R-5 and R-3 Zones, as described by Sections 101.0431, 101.0419, 101.0418 and 101.0411, respectively, the boundaries of such zones to be as indicated on Zone Map Drawing No. B-2269.1, filed in the office of the City Clerk as Document No. 731660.

Section 2. That in the event the zoning restrictions shall attach to the said subdivided land described in Section 1 of this ordinance, Ordinance No. 7854 (New Series), adopted May 1, 1958, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
