AN ORDINANCE INCORPORATING PORTIONS OF LOTS 13 AND 14, BLOCK 9, BROOKES' ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RP ZONE, AS DEFINED BY SECTION 101.0419 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a final parcel map is recorded on portions of Lots 13 and 14, Block 9, Brookes' Addition, in the City of San Diego, California, designated "RP" on Zone Map Drawing No. B-2298, and provided the conditions as required by the City Engineer in Document No. 731801 are met, the provisions of Section 101.0419 of the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into RP Zone, as described by Section 101.0419, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2298, filed in the office of the City Clerk as Document No. 731800.

Section 2. That in the event the zoning restrictions shall attach to said land described in Section 1 of this ordinance, Ordinance No. 12988, approved October 20, 1930, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
