AN ORDINANCE INCORPORATING A PORTION OF JACOB REINER'S SUBDIVISION OF PUEBLO LOT 1103; A PORTION OF BAY VIEW QUARTER ACRES; A PORTION OF BAY VIEW ADDITION; AND A PORTION OF PUEBLO LOT 1103, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RP ZONE, AS DEFINED BY SECTION 101.0419 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 1947 (NEW SERIES), ADOPTED OCTOBER 1, 1940, ORDINANCE NO. 5412 (NEW SERIES), ADOPTED DECEMBER 11, 1952, AND ORDINANCE NO. 9629 (NEW SERIES), ADOPTED MAY 18, 1967, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a portion of Jacob Reiner's Subdivision of Pueblo Lot 1103; a portion of Bay View Quarter Acres; a portion of Bay View Addition; and a portion of Pueblo Lot 1103, in the City of San Diego, California, designated "RP" on Zone Map Drawing No. B-2307.1, are subdivided and a final subdivision map or maps thereof duly recorded and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0419 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into RP Zone, as described by Section 101.0419, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2307.1, filed in the office of the City Clerk as Document No. 732030. Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said subdivided land described in Section 1 of this ordinance, Ordinance No. 1947 (New Series), adopted October 1,

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
