ORDINANCE NO. (New Series)

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 9776 (NEW SERIES), ADOPTED MARCH 14, 1968, INCOR-PORATING PORTIONS OF LOTS 8 AND 9, LEMON VILLA, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO R-4 AND CP ZONES, AS DEFINED BY SECTIONS 101.0413 AND 101.0421 RESPECTIVELY OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 9776 (New Series), adopted March 14, 1968; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 9776 (New Series), adopted March 14, 1968 be, and it is hereby amended to read as follows:

> Section 1. That in the event that portions of Lots 8 and 9, Lemon Villa, in the City of San Diego, California, designated "R-4" and "CP" on Zone Map Drawing No. B-1867.1. are subdivided and a final subdivision map thereof duly recorded on or before July 9, 1970 and within such subdivision, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0413 and 101.0421 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R-4 and CP Zones, as described by Sections 101.0413 and 101.0421 respectively of the San Diego Municipal Code, the boundary of each zone to be
