ORDINANCE NO. 10360 AUG \$ 1970 (New Series)

AN ORDINANCE INCORPORATING PORTIONS OF LOTS 11 AND 12, BLOCK 8, BROOKES ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO RP ZONE, AS DEFINED BY SECTION 101.0419 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, portions of Lots 11 and 12, Block 8, Brookes Addition, in the City of San Diego, California, designated "RP" on Zone Map Drawing No. B-2336, are subdivided and a final parcel map thereof duly recorded, and provided the conditions as required by the City Engineer in Document No. 732422 are met, the provisions of Section 101.0419 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into RP Zone, as described by Section 101.0419, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2336, filed in the office of the City Clerk as Document No. 732421.

Section 2. That in the event the zoning restrictions shall attach to the said subdivided land described in Section 1 of this ordinance, Ordinance No. 12988, approved October 20, 1930, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
