

ORDINANCE NO. **10370** **AUG 20 1970**  
(New Series)

AN ORDINANCE INCORPORATING A PORTION OF VILLA LOT 196, NORMAL HEIGHTS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1A ZONE, AS DEFINED BY SECTION 101.0431 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12989, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Villa Lot 196, Normal Heights, in the City of San Diego, California, within the boundary of the district designated "C-1A" on Zone Map Drawing No. B-2338.1, filed in the office of the City Clerk under Document No. 732552 be, and the same is hereby incorporated into C-1A Zone, as such zone is described and defined by Section 101.0431 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12989, approved October 20, 1930, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
