AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 9898 (NEW SERIES), ADOPTED OCTOBER 24, 1968, INCORPORATING A PORTION OF THE N.W. 1/4 OF THE

S.W. 1/4, SECTION 35, T18S, R2W, SBBM, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1A AND R-5 ZONES, AS DEFINED BY SECTIONS 101.0431 AND 101.0418, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 9898 (New Series), adopted October 24, 1968; and

WHEREAS, the Planning Commission and the City Engineer have no objection to this extension; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 9898 (New Series), adopted October 24, 1968 be, and it is hereby amended to read as follows:

> Section 1. That in the event that a portion of the N.W. 1/4 of the S.W. 1/4, Section 35, T18S, R2W, SBBM, in the City of San Diego, California, designated "C-1A" and "R-5" on Zone Map Drawing No. B-1962.1, is subdivided and a final subdivision map or maps thereof duly recorded on or before November 23, 1971 and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0431 and 101.0418 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated
