ORDINANCE NO. (New Series)

AN ORDINANCE REPEALING ORDINANCE NO. 10366 (NEW SERIES) OF THE CITY OF SAN DIEGO, CALIFORNIA, ADOPTED AUGUST 18, 1970, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL MUNICIPAL BOND ELECTION TO BE HELD IN THE CITY ON NOVEMBER 3, 1970, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY TWO PROPOSITIONS TO INCUR GENERAL OBLIGATION BONDED INDEBTEDNESS BY THE CITY FOR CERTAIN MUNICIPAL IMPROVEMENTS AND CONSOLIDATING THE SPECIAL MUNICIPAL BOND ELECTION WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THE SAME DATE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 10366 (New Series), adopted August 18, 1970, ordering, calling, providing for and giving notice of a special municipal bond election to be held in the City on November 3, 1970, is hereby repealed.

Section 2. This ordinance shall take effect and be in force immediately.
