AN ORDINANCE AMENDING CHAPTER III,  
ARTICLE 1 OF THE SAN DIEGO MUNICIPAL  
CODE BY AMENDING SECTION 31.0353  
RELATING TO LICENSE TAX--AUTOMOBILE  
STORAGE OR PARKING.

BE IT ORDAINED by the Council of The City of  
San Diego as follows:

Section 1. That Chapter III, Article 1 of the  
San Diego Municipal Code be and it is hereby amended  
by amending Section 31.0353 to read as follows:

SEC. 31.0353 LICENSE TAX--AUTOMOBILE STORAGE  
OR PARKING.

Every person conducting, managing, or carrying  
on any automobile storage or parking place shall  
pay a license tax of Twenty-Five Dollars (\$25.00)  
per year per storage area or lot plus Two Dollars  
(\$2.00) per year per employee for the average  
number employed during the preceding six (6) months,  
payable annually.

Section 2. This ordinance shall take effect and be  
in force on the thirtieth day from and after its passage.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


