SEC. 31.0367 LICENSE TAX--BARBER SHOPS

Every person conducting, managing or operating any barber shop shall pay annually a license tax of Twenty-five Dollars (\$25) per year plus Two Dollars (\$2) per year per employee for the average number employed during the preceding six (6) months.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
