ORDINANCE NO. 10392 SEP 1 1970

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 9777 (NEW SERIES), ADOPTED MARCH 14, 1968, INCORPORATING LOTS 95, 99, 100 AND 105, BOULEVARD GARDENS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 9777 (New Series), adopted March 14, 1968; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 9777 (New Series), adopted March 14, 1968 be, and it is hereby amended to read as follows:

Section 1. That in the event that Lots 95, 99, 100 and 105, Boulevard Gardens, in the City of San Diego, California, designated "M-lA" on Zone Map Drawing No. B-1869, are subdivided and a final subdivision map or maps thereof duly recorded on or before October 14, 1970 and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0436 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into M-lA Zone, as described by Section 101.0436, the boundary of such zone to be as indicated on Zone Map Drawing No. B-1869, filed in the office of the City Clerk as Document No. 720475. Said zoning shall attach only to those properties included in

the subdivision map or maps recorded as provided in this Section.

This ordinance shall take effect and be in Section 2. force on the thirtieth day from and after its passage.
