AN ORDINANCE PREZONING A PORTION OF SECTION 9, AND A PORTION OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 16, TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M., (GONZALES CANYON ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA INTO A-1-10 ZONE AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That a portion of Section 9, and a portion of the Northwest 1/4 of the Northwest 1/4 of Section 16, Township 14 South, Range 3 West, S.B.B.M., (Gonzales Canyon Annexation), in the County of San Diego, California, within the boundary of the district designated "A-1-10" on that certain Zone Map Drawing No. B-2354, filed in the office of the City Clerk under Document No. 732793 be, upon annexation to The City of San Diego, incorporated into A-1-10 Zone as defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
