AN ORDINANCE INCORPORATING A PORTION OF LOT 44, RANCHO MISSION OF SAN DIEGO (A PORTION OF SILVER SPRINGS ANNEXATION), IN THE CITY OF SAN DIEGO, CALIFORNIA, A-1-1 ZONE AS DEFINED BY SECTION 101.0404 (R-5 UPON RECORDATION OF MAP OR MAPS, AS DEFINED BY SECTION 101.0418) OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 44, Rancho Mission of San Diego (a portion of Silver Springs Annexation), in the City of San Diego, California, within the boundary of the district designated "A-1-1" on that certain Zone Map Drawing No. B-2229.1, filed in the office of the City Clerk under Document No. 731279 be, and it is hereby incorporated into A-1-1 Zone as defined by Section 101.0404 of the San Diego Municipal Code; provided, however, that if within two years of the effective date of this ordinance the said described area is subdivided and a final subdivision map or maps thereof duly recorded and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the said subdivided land shall be incorporated into R-5 Zone as described by Section 101.0418 of the San Diego Municipal Code. Said R-5 Zoning shall attach only to those areas included in the subdivision map or maps.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
