AN ORDINANCE AMENDING ORDINANCE NO. 10334 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1970-71 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," AS AMENDED BY ORDINANCE NO. 10372 (NEW SERIES).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Section 1 of Ordinance No. 10334 (New Series) entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1970-71 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," as amended by Ordinance No. 10372 (New Series), be and the same is hereby amended to read as follows:

"Section 1. The Budget for the expense of conducting the affairs of The City of San Diego for the fiscal year commencing July 1, 1970, heretofore prepared and submitted to this Council by the City Manager and on file in the office of the City Clerk under Document No. 731769, as amended by Document No. 732462, and as further amended by Document No. 732986, is hereby adopted as the Annual Budget for said fiscal year. Said Budget is further amended in the manner set forth in that document on file in the office of the City Clerk as Document No. 733431."

Section 2. Section 2 of said Ordinance No. 10334 (New Series), as amended by Ordinance No. 10372 (New Series), be and the same is hereby amended to add thereto an additional paragraph as follows:

"V. COMMUNITY CONCOURSE OPERATIONS FUND


