AN ORDINANCE AMENDING CHAPTER III,
ARTICLE 4 OF THE SAN DIEGO MUNICIPAL
CODE BY AMENDING SECTION 34.03 RELATING
TO LICENSES AFFIXED TO BICYCLES.

BE IT ORDAINED by the Council of The City of
San Diego as follows:

Section 1. That Chapter III, Article 4 of the
San Diego Municipal Code be and the same is hereby
amended by amending Section 34.03 to read as follows:

SEC. 34.03 LICENSE AFFIXED TO BICYCLE

The City of San Diego, through the San Diego
Fire Department or any other department designated
by the City Manager, shall provide a paper license
tab with registration cards, such license tabs
and registration cards having numbers in numerical
order; such license tabs shall be attached to the
frame of the bicycle near the seat. It shall be
the duty of the issuing agency to attach such license
tabs to the bicycle and issue a corresponding
registration card to the licensee upon the payment
of the license fees herein provided for. Such
license tabs shall remain attached to the bicycle
during the term for which the license is issued.
The Chief of Police shall keep a record of the date
of issue of each license, to whom issued, and the
number thereof.

Section 2. This ordinance shall take effect and be
in force on the thirtieth day from and after its passage.
