

ORDINANCE NO. 10421 OCT 1 1970
(New Series)

AN ORDINANCE INCORPORATING LOT 1889, MISSION VILLAGE UNIT NO. 21, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8757 (NEW SERIES), ADOPTED NOVEMBER 27, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HERewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 1889, Mission Village Unit No. 21, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-2330.1, filed in the office of the City Clerk under Document No. 733120 be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8757 (New Series), adopted November 27, 1962, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
