ORDINANCE NO. 10428 OCT 13 1970 (New Series)

AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 5, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE RELATING TO THE REGULATION OF OUTDOOR ADVERTISING DISPLAYS BY ADDING SECTION 95.0327.

WHEREAS, it is the purpose and intent of the City Council in enacting this ordinance to extend the regulatory provisions of Chapter IX, Article 5, Division 3, of the San Diego Municipal Code, pertaining to the regulation of outdoor advertising displays, to that portion of State Highway 109 from the westerly end of Interstate 8 to South Mission Bay Drive; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 5, Division 3, of the San Diego Municipal Code be, and the same is hereby amended by adding Section 95.0327 to read as follows:

SEC. 95.0327 STATE HIGHWAY 109 - REGULATED

It is found, determined and declared by the City Council of The City of San Diego that that portion of State Highway 109 from the westerly end of Interstate 8 to South Mission Bay Drive is within the regulatory provisions of this division.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
