AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED BY ORDINANCES NOS. 10326 (NEW SERIES) AND 10402 (NEW SERIES), TO CREATE THE UNCLASSIFIED POSITION OF MANAGEMENT ASSISTANT AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10300 (New Series) of the ordinances of The City of San Diego, as amended by Ordinance No. 10326 (New Series) and 10402 (New Series) is hereby amended to create and establish the unclassified position of Management Assistant.

Section 2. As the schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Standard Rates of pay established and adopted by Ordinance No. 10300 (New Series), as amended by Ordinances Nos. 10326 (New Series) and 10402 (New Series), of the ordinances of said City, is hereby adopted:



BE IT ORDAINED, by the Council of The City of San Diego, as follows:
