AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED BY ORDINANCE NO. 10326 (NEW SERIES) AND ORDINANCE NO. 10402 (NEW SERIES), TO CREATE THE CLASSIFIED POSITIONS OF CLAIMS REPRESENTATIVE AND SUPERVISING CLAIMS REPRESENTATIVE AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.


