ORDINANCE NO. 10444 (New Series)

AN ORDINANCE INCORPORATING LOT 15, BLOCK 3, DRUCKER'S SUBDIVISION, MAP 1584, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 4407 (NEW SERIES), ADOPTED MAY 16, 1950, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, the conditions as required by the City Engineer in Document No. 733646 are met, with reference to Lot 15, Block 3, Drucker's Subdivision, Map 1584, in the City of San Diego, California, designated "C-1" on Zone Map Drawing No. B-2381.1, the provisions of Section 101.0430.1 of the San Diego Municipal Code shall attach and become applicable to said lot and said lot shall be incorporated into C-1 Zone as described by Section 101.0430.1 of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2381.1, filed in the office of the City Clerk as Document No. 733645.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 4407 (New Series), adopted May 16, 1950,
