AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 241, 242, 243 OF THE PUEBLO LANDS OF SAN DIEGO, AND LOTS 1 THROUGH 9, GULLS ACRES, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 34 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That portions of Pueblo Lots 241, 242, 243 of the Pueblo Lands of San Diego, and Lots 1 through 9, Gulls Acres, in the City of San Diego, California, within the boundary of the district designated "C-1" on Zone Map Drawing No. B-2386, filed in the office of the City Clerk under Document No. 733834 be, and it is hereby incorporated into C-1 Zone, as such zone is described and defined by Section 101.0430.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 34 (New Series), adopted September 12, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
