

ORDINANCE NO. 10448
(New Series)

AN ORDINANCE INCORPORATING LOTS 5 THROUGH 8, BLOCK 240, PACIFIC BEACH, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO C-1A ZONE, AS DEFINED BY SECTION 101.0431 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 119 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HERewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded consolidating Lots 5 through 10, and a portion of Lot 11, Block 240, Pacific Beach, and provided the conditions as required by the City Engineer in Document No. 733831 are met, the provisions of Section 101.0431 of the San Diego Municipal Code shall attach and become applicable to Lots 5 through 8, Block 240, Pacific Beach, which area is designated C-1A on Zone Map Drawing No. B-2382, filed in the office of the City Clerk as Document No. 733832.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 119 (New Series), adopted January 3, 1933, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
