

ORDINANCE NO. 10459 DEC 15 1970
(New Series)

AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED BY ORDINANCES NOS. 10326 (NEW SERIES) AND 10402 (NEW SERIES), TO CREATE THE CLASSIFIED POSITIONS OF DEPUTY MODEL CITIES DIRECTOR, MODEL CITIES TECHNICIAN II AND MODEL CITIES TECHNICIAN I, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10300 (New Series) of the ordinances of The City of San Diego, as amended by Ordinances Nos. 10326 (New Series) and 10402 (New Series), is hereby amended to create and establish the classified positions of Deputy Model Cities Director, Model Cities Technician II and Model Cities Technician I.

Section 2. As the schedule of compensation for the positions created in Section 1 hereof, the following standard rate numbers of the Table of Standard Rates of Pay established and adopted by Ordinance No. 10300 (New Series), as amended by Ordinances Nos. 10326 (New Series) and 10402 (New Series), of the ordinances of said City, are hereby adopted.

Section 4. The positions of Model Cities Technician II and Model Cities Technician I shall be inserted in Exhibit B of Ordinance No. 10300 (New Series), as amended by Ordinances Nos. 10326 (New Series) and 10402 (New Series), under the general category PLANNING AND COMMUNITY DEVELOPMENT after the position of Planning Technician I.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED BY ORDINANCES NOS. 10326 (NEW SERIES) AND 10402 (NEW SERIES), TO CREATE THE CLASSIFIED POSITIONS OF DEPUTY MODEL CITIES DIRECTOR, MODEL CITIES TECHNICIAN II AND MODEL CITIES TECHNICIAN I, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10300 (New Series) of the ordinances of The City of San Diego, as amended by Ordinances Nos. 10326 (New Series) and 10402 (New Series), is hereby amended to create and establish the classified positions of Deputy Model Cities Director, Model Cities Technician II and Model Cities Technician I.
