AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 84.03 RELATING TO VEHICLES ON PRIVATE  
PROPERTY.

BE IT ORDAINED by the Council of The City of San Diego  
as follows:

Section 1. That Chapter VIII, Article 4 of the  
San Diego Municipal Code be and it is hereby amended by  
amending Section 84.03 to read as follows:

SEC. 84.03 VEHICLES ON PRIVATE PROPERTY

(a) It shall be unlawful for any person to  
operate or drive or leave any vehicle in, over,  
or upon any private property without the written  
permission of the owner thereof, or the person  
entitled to the immediate possession thereof, or  
the authorized agent of either.

(b) Whenever any person is stopped by a peace  
officer pursuant to this Section, he shall, upon  
the request of such peace officer, display said  
written permission.

Section 2. This ordinance shall take effect and  
be in force on the thirtieth day from and after its  
passage.


