

ORDINANCE NO. 10471 DEC 31 1970
(New Series)

AN ORDINANCE INCORPORATING BLOCK "B," NETTLESHIP TYE TRACT NO. 2 AND LOTS 1 THROUGH 6, EL KHADEM PARK, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-10 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 119 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HERewith.

BE IT ORDAINED, by the Council of The City of San Diego
as follows:

Section 1. That Block "B," Nettleship Tye Tract No. 2 and Lots 1 through 6, El Khadem Park, in the City of San Diego, California, within the boundary of the district designated "R-1-10" on Zone Map Drawing No. B-2398, filed in the office of the City Clerk under Document No. 733997 be, and it is hereby incorporated into R-1-10 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 119 (New Series), adopted January 3, 1933, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
