

RESOLUTION NO. 198812

APPROVING MAP OF ALVARADO PLAZA UNIT NO. 4 SUBDIVISION
AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE
EASEMENT GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by THOMAS E. CRAIG, Registered Civil Engineer, and entitled,
"ALVARADO PLAZA UNIT NO. 4 Being a subdivision of a portion
of Lot 67 of Rancho Mission of San Diego, in the City of San
Diego, County of San Diego, State of California, according to
partition map thereof made in the action entitled 'Juan M. Luco,
et al, vs. the Commercial Bank of San Diego, et al' under
Superior Court Case No. 348 on file in the office of the County
Clerk of San Diego County.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys; that
said map and the subdivision of land shown thereon is hereby
approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the easement with the right of ingress and egress for the
construction and maintenance of drainage facilities as granted
and shown on said map and subject to the conditions set forth
thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map as and for the act of the Council
that said Council has approved said subdivision map and that
that certain easement with the right of ingress and egress for
the construction and maintenance of drainage facilities as granted
and shown on this map within this subdivision is accepted on behalf
of The City of San Diego, a municipal corporation, as above
stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
